MEDICALLY RELATED TRAVEL, LODGING, AND PER DIEM: Your Veterans Health Benefits Handbook (VHBH) will tell you what benefits you are entitled to for medically related travel, lodging, and per diem. My VHBH states on page 20, Chapter 3, for "MILEAGE REIMBURSEMENT: You are eligible to be reimbursed 41.5 cents per mile, for your travel related to obtaining VA health care services. You are also eligible for travel reimbursements when you travel to a VA facility or VA-authorized health care facility for a scheduled Compensation and Pension (C&P) examination."
- 3. VETERAN ID CARD: In July, 2015, President Obama signed into law the Veterans Identification Card Act of 2015. This act allows veterans to apply for an identification card directly from the VA. The card will allow Veterans to demonstrate proof of service for discounts at private restaurants and businesses. The Veterans ID Card is different from a Veteran Health ID Card. It is estimated the program will be implemented in 2017 and is taking longer because the VA is trying to implement the program in the most efficient and cost-effective way possible.

  - COLD WAR RECOGNITION CERTIFICATE: Complete an <u>Application for Cold War</u>
